NOTICE TO VESSEI	OWNERS AND OP	PERATORS	

- 1. All vessels must register at the harbor office. All berth assignments shall be at the direction of the Wharfinger.
- The Wharfinger may move vessels at any time for the needs and operations of the Harbor.
- 3. Persons registering a vessel with the Port of San Francisco must provide the Wharfinger with valid identification.
- Transient vessel dockage fees are payable in advance.
- 5. It is unlawful to depart without paying all fees due.
- The harbor is a **NO WAKE ZONE**. No vessel is to exceed 5 mph.
- 7. No person shall discharge human waste, fish parts, garbage or any other waste into the waters of the harbor.
- 8. Fueling of any vessel or motor, except at the fuel dock is prohibited.
- 9. Discharging any solid or liquid wastes, including bilge water, gray water or sewage into the harbor is prohibited.
- 10. Maintenance of vessels must be done within the confines of the vessel.
- 11. Spray painting or sanding the exterior of a boat is prohibited.
- 12. No advertising, soliciting or sales are permitted on transient vessels.
- 13. No fishing or swimming in the harbor.
- 14. No feeding or harassment of sea lions, birds or other wildlife.
- 15. Dogs must be leashed to and from vessels. No pet waste is to be discharged into the water of the harbor.

Berthing privileges have been granted to the above vessel upon the express condition that the City and County of San Francisco and the San Francisco Port Commission are to be free from liabilities and claims for damages and lawsuits for, or by reason of, any injury or injuries to any person or persons, or property of any kind whatsoever from any cause or causes whatsoever occurring on, or arising out of, the use of Port premises in connection with this berthing privilege. The undersigned, whether as owner, agent or consignee of said vessel, hereby personally guarantees the payments of all dockage and all other charges contracted for by said vessel or arising out of damage occurring in connection with this berthing privilege or any assumption of liability provided for herein.
