## Berth Holder Internal Move Request Annual Fee \$100

When a berth becomes available, we see this as an opportunity to accommodate the needs of our tenants. If an opening matches your particular needs and you are next on the Internal Move List, we will arrange your relocation. The Internal Move List order is determined by date of request. If you have special circumstances, we encourage you to contact the office 415.495.4911. The Assistant Harbormaster, and/or representatives will measure the vessel for compliance prior to approval of any internal moves.

As stated on the Conditional License Agreement, Side-Ties do not require a Wait List Account, they are not considered on the Internal Move Lists for that reason. Side-tie tenants have all of the tenant privileges except Internal Moves to berths 26' and larger. Side-ties are for vessels "under 20 feet only", and they must be measured for approval. Side-tie vessels pay a per-foot rate.

## Berth Holder Internal Move Request Annual Fee \$100

I understand that the move to a new berth is contingent upon a boat inspection to verify that the boat fits the LOA and beam space for the berth along with current boat registration or USCG documentation.

I also understand that current insurance w/the SF Port Additional Insured Endorsement language is required by the Port of San Francisco through Exigis LLC. **The annual fee to stay on the internal move list is \$100 a year and it must be paid to remain on the Internal Move list.** Tenants who request to move internally must keep their account in "Good Standing" with current balances, partnerships agreements, and contracts.
