CMD Award Recommendation

The Contract Monitoring Division ("CMD") has reviewed the bids submitted for the above-referenced project and determined responsiveness to the Federal SBE pre-award requirements.

A Federal SBE sub-contracting goal of 20% was established for this project. The Apparent Low Bidder, Power Engineering Construction Co. (Power Engineering) submitted a bid for \$1,419,896.

Four Bidders submitted bids as follows:

The CMD has determined that Power Engineering, the apparent low bidder, is responsive to the 20% SBE subcontracting goal established for this project.

Power Engineering met the 20% SBE subcontracting participation requirement by listing the following firms on Section 00 43 50 of the bid. (Proposed Subcontractor Form, SBE Form 2A) and on SBE/DBE Form1, Bidder and Subcontractor Participation Report
